

RURAL MUNICIPALITY OF MORRIS

The Council of the Rural Municipality of Morris held a Special Meeting at 10:00 A.M. on Thursday, February 27th, 1986 in the Council Chambers of the R. M. of Morris.

Reeve Dan Thiessen presided.

Present were Councillors: George St. Hilaire, W. F. Recksiedler, Larry Gluck, Dave Waldner, Glenn Curdt, Don Hamblin.

The purpose of this special meeting was to continue with matters remaining from the February 13th, 1986 regular meeting.

- Anderson Subdivis. Moved by Donald Hamblin, Seconded by W. F. Recksiedler: #46/86. Whereas Katherine C. Anderson and Charles W. Anderson have made application to subdivide part of the SW $\frac{1}{4}$  of Section 2-5-1W.P.M. given palnning file no. 36-85-2559; Therefore Be It Resolved that the Council of the Rural Municipality of Morris does now approve the subdivision subject to the condition that a variation order be obtained for the 5 acre parcel and also that the owner is financially responsible for any new approaches or crossings required because of this subdivision.

- Nuclear Waste Sites in U.S.A. Moved by Dave Waldner, Seconded by Glenn Curdt: #47/86. Whereas the United States Government has recently indicated that they are considering an underground nuclear waste repository site close to the Manitoba border with the United States; And Whereas many of the possible sites chosen for this nuclear waste repository are within the Red River Valley watershed area; Therefore Be It Resolved that the Rural Municipality of Morris is strongly opposed to a nuclear waste repository site being located in the state of Minnesota or in the state of North Dakota or in any location in the Red River Valley water basin.

- Order Material Moved by Dave Waldner, Seconded by George st. Hilaire: #48/86. Resolved that we authorize the ordering and purchase of the following items:  
- checkerboard signs  
- 4 new michelin grader tires  
- recapping and repairing if needed of 4 michelin tires  
- 2 new standard grader tires  
- no parking signs for the fire hall entrances.

- Drain Sec.9&10-5-1E Moved by Dave Waldner, Seconded by George St. Hilaire: #49/86. Resolved that the Water Resources Branch be requested to prepare the drain design for a proposed drain North of the NE $\frac{1}{4}$  of Section 9-6-1E. and North of the NW $\frac{1}{4}$  of Section 10-6-1E.

- Culvert Morris Riv. Moved by Dave Waldner, Seconded by Glenn Curdt: #50/86. Resolved that we request the Water Resources Branch to provide recommended culvert sizings for a crossing on the Morris River located one mile south of Rosenort.  
Carried.
- Massey-Fer. Tractor Moved by W. F. Recksiedler, Seconded by Don Hamblin: #51/86. Resolved that we offer for sale by tender bid the Massey-Ferguson tractor.  
Carried.
- Lowe Farm C.C.D. Budget Moved by Larry Gluck, Seconded by George St. Hilaire: #52/86. Resolved that the 1986 budget for the Lowe Farm Community Recreation District in the amount of \$8,730.00 be now approved.

Therefore Be It Resolved that the R. M. of Morris does hereby now allocate at least 1/3 of the 1986 Provincial Recreation Facilities Grant to the Valley Recreation Centre facility.

#54/86. Resolved that the R. M. of Morris authorize the engaging of legal counsel to represent the municipality for a legal suit against Adella Thiessen and that the Reeve and Secretary-Treasurer are authorized to chose proper legal counsel.

Work for Crawlers Moved by Glenn Curdt, Seconded by Larry Gluck:  
#55/86. Resolved that our crawlers are authorized to do custom work this winter and that the rate be set at \$100.00 per hour for such work this winter with a minimum charge of \$100.00.
