Minutes Moved by George St. Hilaire, Seconded by W. F. Recksiedler:
#91/86. Resolved that the minutes of the April 10, 1986 regular meeting be now adopted as presented.
Carried.

Municipal Float Moved by George St. Hilaire, Seconded by Larry Gluck:
#92/86. Resolved that we enter the municipal float in the Shannon Festival Parade and in the Sunflower Festival Parade and in the Morris Stampede Parade.
Carried.

E. Roy Subdivision RL 444&446 Moved by George St. Hilaire, Seconded by Dave Waldner:
#93/86. Whereas Mrs. Ella Roy has made application to subdivide part of River Lots 444 and 446, Plan 4121, given planning file no. 36-86-2592;
Therefore Be It Resolved that the Council of the Rural Municipality of Morris does now approve this subdivision.

#94/86. Resolved that the Council of the Rural Municipality of Morris does now resolve into the Variation Board of the R. M. of Morris to consider application no. 2/86 from Mr. Charles Anderson.

#95/86. Whereas Mr. Charles Anderson is the owner of the SW¼ of Section 2-5-1W.P.M.;
And Whereas Mr. Charles Anderson has applied for a variation order to allow for a site area of 5.5 acres in a 40 acre zoning;
Therefore Be It Resolved that the Variation Board of the R. M. of Morris does now approve this application no. 2/86 for Mr. Charles Anderson.

By-law 1320/86 Moved by Dave Waldner, Seconded by George St. Hilaire:
#97/86. Whereas By-law No. 1320/86, being our 1986 levy by-law, was given first reading on March 27, 1986;
And Whereas this by-law is now available to be given second and third readings;
Therefore Be It Resolved that the R. M. of Morris does now give second and third readings to By-law No. 1320/86 and finally passed in Council as a whole with the requirements of Section 183(2) and 183(3) of the Municipal Act being now suspended.

#98/86. Whereas Section 758 of the Municipal Act provides that a municipality may add certain assessments to the tax roll;
And Whereas the Council of the Rural Municipality of Morris has received a listing from the Morden Municipal Assessment Branch indicating certain property assessments which may be added to the assessment roll for the R. M. of Morris;
Therefore Be It Resolved that the Council of the Rural Municipality of Morris does now authorize that the property assessments listed from the Morden Municipal Assessment Branch in their letter dated April 16, 1986 be now added to the assessment roll for the R. M. of Morris for the year 1986 as may be amended by Council.

Gravel Checker & Scale Operator Moved by George St. Hilaire, Seconded by Glenn Curdt:
#99/86. Whereas the Rural Municipality of Morris has requested applications for the position of gravel checker and scale operator for the 1986 gravel program;
And Whereas a number of applications have been received;
Therefore Be It Resolved that Mr. Rene Saurette be engaged as Gravel Checker at a salary of \$7.00 per hour plus mileage, and also that Mr. Walter Sorokowski be hired as scale operator at a salary of \$6.50 per hour.

#100/86. Resolved that Mr. Jake F. Klassen be engaged as mower operator and tree planter for the R. M. of Morris for the 1986 season at a salary of \$10.00 per hour.

Rates Filling Reservoirs Moved by Dave Waldner, Seconded by Larry Gluck:
#101/86. Resolved that we authorize the following rates to those persons pumping water into the reservoirs at Lowe Farm and at Rosenort:
\$6.50 per hour for the day shift
\$7.50 per hour for the night shift

V.H.F. Radios Moved by Donald Hamblin, Seconded by George St. Hilaire:
#102/86. Resolved that we authorize the purchase of 8 V.H.F. radios from Dyck's T.V. and Radio at the price quoted in his letter of April 30, 1986 and that the tower and base be located at the shop with a remote unit being in the municipal office.

Speed Limits Rosenort Moved by Dave Waldner, Seconded by Larry Gluck:
#103/86. Resolved that the Rural Municipality of Morris request the Highway Traffic Board to establish speed limits along the urban streets within the boundaries of the Unincorporated Village District of Rosenort and beyond, and that the speed zones requested shall be as follows:
1) 50 Km./Hr. for all streets north of P.R. 205 and also those streets south of P.R. 205 within the boundaries of the dyke.
2) 70 Km./Hr. for that government road allowance East of Section 5-6-1E.P.M. and East of Section 32-5-1E.P.M. and also the side roads intersecting this road to a distance corresponding to the boundaries of the U.V.D. of Rosenort.
3) that reduced speed zones be established for school zone areas within the boundaries of the U.V.D. of Rosenort.
4) 70 Km./Hr. for the government road allowance which proceeds through section 29-5-1E.P.M.
Carried.

Speed Limits Sperling Moved by Glenn Curdt, Seconded by W. F. Recksiedler:
#104/86. Resolved that the Rural Municipality of Morris request the Highway Traffic Board to establish a speed limit of 50 Km./Hr for all urban streets of Sperling, Manitoba located within the West half of Section 29, Township 6 and Range 2 West of the Principle Meridian and also that reduced speed for school zone areas be appropriately designated.

Resolved that the Rural Municipality of Morris request the Highway Traffic Board to set a speed limit of 50 Km./Hr. for all urban streets of Lowe Farm, Manitoba located within the South half of Section 6, Township 5 and Range 1 West of the Principle Meridian and also that reduced speed for school zone areas be appropriately designated.
