Delegation

Conditional Use

D. Heinrichs Moved by David Waldner, Seconded by George St. Hilaire: #114/86. Whereas Mr. Diedrich Heinrichs and Mrs. Phyllis E. Heinrichs are the owners of Lot 8, Plan 16468, being part of the NE% of Section 31-5-1E.P.M.;

And Whereas Diedrich Heinrichs and Phyllis E. Heinrichs have applied for a conditional use to operate a 25,000 poultry livestock feedlot operation on the above mentioned property which is in an "A40" Rural District zoning area;

Therefore Be It Resolved that the Council of the Rural Municipality of Morris after careful consideration of the application for this conditional use does now give approval to this Conditional Use Order No. 3/86 for Mr. Diedrich Heinrichs and Mrs. Phyllis E. Heinrichs.

Siemens has applied for a conditional use to operate a 380 head of cattle livestock feedlot operation on the above mentioned property;

And Whereas this property is in an "A40" Rural Distict zoning area; Therefore Be It Resolved that the Council of the Rural Municipality of Morris after careful consideration of the application for this conditional use now gives approval to Conditional Use Order No. 1/86 for Mr. Jack D. Siemens.

Siemens is the owner of Lot 6, Plan 17330, being part of the SE½ of Section 31-5-1E.P.M.; And Whereas Mr. Jack D. Siemens has applied for a conditional use to operate a 25,000 poultry livestock feedlot operation on the above mentioned property;

And Whereas this property is in an "A40" Rural District zoning area; Therefore Be It Resolved that the Council of the Rural Municipality of Morris after careful consideration of the application for this conditional use now gives approval to Conditional Use Order No. 2/86 for Mr. Jack D. Siemens.

Whereas the Province of Manitoba is purchasing .045 hectares of land from James Heinrichs and Diedrich Heinrichs designated as Parcel "A", being part of the NW_4 of Section 6-6-1E.P.M.; And Whereas this property is to be used for drainage purposes; And Whereas the Province of Manitoba plans to convey this property to the Rural Municipality of Morris to maintain for drainage purposes;

Therefore Be It Resolved that the Council of the Rural Municipality of Morris now accepts this proposal and its conditions.
