And Further Be It Resolved that because of extra staffing, etc., that a commission of at least 3% will be required for municipal purposes.

Grant-in-Aid Lowe Farm Sperling

And Whereas the Rural Municipality of Morris has 1st Street, 3rd Street, 5th Street, Reimer Street from P.T.H. 23 to 1st Avenue and 1st Avenue from 5th Street to Reimer Street in Lowe Farm, Manitoba which are grant-in-aid streets; And Whereas the Rural Municipality of Morris has a portion of Elevator Street, Station Street, Waddell Street and New Street in Sperling, Manitoba which are grant-in-aid streets; Therefore Be It Resolved that the Rural Municipality of Morris does now apply for grant-in-aid work on the above mentioned streets for te year 1988 and the total cost for the streets in Lowe Farm is to be \$4,500.00 and the total cost for te streets in Sperling in to be \$3,000.00 which is to consist of calcium chloride and/or lignosulfonate, gravel, grading, etc.
