Whereas a company is planning to construct a communications tower on River Lots 344 to 352 east of P.R. 246; And Whereas this site location has been approved by the Department of Transport and will not interfere with any other towers in the area;

Therefore Be It Resolved that the R. M. of Morris does not object to the construction of this communication tower and requires only that a building permit be taken out for the construction of the tower and any accessory buildings to be located on the site.

Moved by Harold Dyck, Seconded by W. E. Martens: 94/89. Whereas the Rural Municipality of Morris has experienced considerable difficulty in being able to supply sufficient quantities of treated water from the Lowe Farm Water Treatment Plant; And Whereas the R. M. of Morris plans to install an additional filter and improvements to the treatment plant to improve the availability of treated water from this plant; And Whereas the R. M. of Morris intends to provide this upgrading during the summer of 1989; And Whereas the R. M. of Morris plans to engage the services of

And Whereas the R. M. of Morris plans to engage the services of J. R. Cousin Consultants for this upgrading of the Lowe Farm plant; Therefore Be It Resolved that the Water Services Board be requested to provide financial assistance for this upgrading work to be done to the Lowe Farm Treatment Plant and that an agreement be reached with J. R. Cousin Consultants to provide the engineering services for this project.

Carried.

The Council then engaged in a review of the 1989 municipal budget proposals. There was a review of the revenue, expenditures, mill rates projected for the 1989 year and Councils desire to maintain the municipal portion of the mill rates at the level they were at in 1988. The budget proposal would then be recalculated and adjusted accordingly and may require a further meeting.

This special meeting was then adjourned at approximately 4:00 P.M.
