The Council of the Rural Municipality of Morris held its regular meeting at 10:00 A.M. on Thursday, April 12th, 1990 in the Council Chambers of the R. M. of Morris.

Reeve Dan Thiessen presided. Present were Councillors: George St. Hilaire, Allan Dickson, Bill Martens, Glenn Curdt, Harold Dyck.

Minutes

Moved by Allan Dickson, Seconded by W. E. Martens: #92/90. Resolved that the minutes of the March 8th, 1990 regular meeting and the March 19th, 1990 special meeting be now adopted as presented.

Coalition Member

Moved by Glenn Curdt, Seconded by George St. Hilaire: #93/90. Resolved that the Rural Municipality of Morris purchase a membership into The International Coalition at a cost of \$290.00 Canadian funds and that this amount be authorized to be paid. Carried.

River Rd. South Upgrading Contribut. Moved by Allan Dickson, Seconded by Harold Dyck: #94/90. Whereas the R. M. of Morris has previously authorized support for the River Road South upgrading construction project by a monetary contribution of \$15,000.00; Therefore Be it Resolved that the R. M. of Morris authorize that this allocation of funds be done in 1990 for the 1990 construction project.

Council then recessed for lunch at 12:15 P.M. and reconvened at 1:20 P.M.

Councillor Glenn Curdt was unable to attend the afternoon session of the Council meeting due to his being required at a meeting in Winnipeg concerning the Carman Hospital.

Delegation

Mr. Fred Gatchell from Roland, Manitoba met with Council to discuss the placement of calcium chloride on roads for homeowner use. His request was to know if Council is interested in using this type of calcium placement. If there is sufficient interest in neighboring municipalities, he would then purchase a truck and tank for this product. The truck would have a 2,000 gallon tank and the calcium would be put on through a gravity flow and not pressure spray as is used by the existing companies. The cost would be \$150.00 for the application of 500 gallons which would cover approximately 300 feet of road.

Condit.Use Hearing No. 2/90 The floor was then opened to presentations at 1:30 P.M. concerning the public hearing for conditional use application no. 2/90. Present for this hearing were Mr. Alvin Rempel and Mr. Jim Heinrichs representing the Rosenort Chamber of Commerce. This hearing concerned the establishment and expansion of the Rosenort Nuisance Grounds. The delegation posed questions relating to the proposed operation, set up, precautions being taken, dumping restrictions, burning, etc. The delegation was informed that our information at this time was that burning would be allowed. The operating costs are basically unknown except that Siemens Plumbing & Heating have been contacted to use their small crawler and dozer to clean the dump site once per week. At present, the site is not planned to be manned and the site would therefore remain open. Council expressed the fact the areas would have to be set aside at the nuisance grounds to accomodate material such a concrete or large metal items. There was also discussion regarding the garbage which sometimes falls off vehicles along the road to the dump, and it was felt that this was indeed a problem however, a simple solution to the problem was not available.

The representatives from the Chamber of Commerce stated that they were not objecting to the Conditional Use, however, they felt a need to express their concerns concerning the operation of the proposed site.

Mr. Weldon Hiebert was also present at the hearing but did not make any presentation to Council.

Condit.Use Hearing No. 1/90 The floor was then opened to presentations at 2:05 P.M. concerning the public hearing for conditional use application no. 1/90. Mr. Jake Falk and Mrs. Tina Falk were present to object to the use of this proposed site as a nuisance grounds. Mr. Falk stated that the mess from the previous site was a very great inconvenience. The garbage had to be picked from the field and that fencing the site was not the total answer because lighter material such as plastic or paper are lifted over the fence and onto the field. Mr. Falk expressed the opinion that properties that are neighboring to a nuisance grounds should receive a tax concession because of the grabage, etc. flying onto the field. Council explained to Mr. Falk that they will be attempting to keep
