The Council of the Rural Municipality of Morris held its regular meeting at 9:00~A.M. on Thursday, July 12th, 1990 in the Council Chambers of the R. M. of Morris.

At the start of the meeting, Council was informed that Councillor Dave Waldner had submitted his resignation as a member of Council on July 10th, 1990.

Minutes

Moved by W. E. Martens, Seconded by Glenn Curdt: #175/90. Resolved that the minutes of the June 14th, 1990 regular meeting and the June 27 and July 4, 1990 special meetings be now adopted as presented.
