Smith Spur Cleanup Moved by Allan Dickson, Seconded by George St. Hilaire: #300/90. Whereas the Smith Spur siding was not left in a proper condition with the removal of the elevator annex; And Whereas Manitoba Pool Elevators is will to pay the cost of cleaning this site;

And Whreas the Canadian National Railways has no objections to this work being done provided that a Release of Liability and Permit form is completed;

Permit form is completed; Therefore Be It Resolved that the R. M. of Morris agrees to perform this work, depending on time and equipment availability, with expenses being paid by Manitoba Pool Elevators at a cost of \$1,000.00;

And Be It Further Resolved that a Release of Liability and Permit form be signed on behalf of the R. M. of Morris for the Canadian National Railway.

Culvert Size Bell Drain Moved by Bill Martens, Seconded by D. Zacharias: #303/90. Resolved that Water Resources Branch be requested to conduct a survey and culvert size recommendations for the Bell Drain located in the R. M. of Morris.

Friction Guard Moved by W. E. Martens, Seconded by D. Zacharias: #304/90. Resolved that the R. M. of Morris authorize the purchase of 2-20 litre plus 4 litre packages of Friction Guard at a cost of \$396.00 per package from Friction Man.
