Moved by George St. Hilaire, Seconded by Harold Dyck: #192/91. Whereas Council has received a letter dated July 16, 1991 from the Municipal Assessment Branch recommending cancellations for 1991;

Drainage Standard Moved by W. E. Martens, Seconded by Glenn Curdt: #203/91. Whereas in many areas of Manitoba the drainage of agricultural lands is a necessary ingredient of conservation; And Whereas the most recent Manitoba Provincial budget has reduced the funding available to the Department of Natural Resources; And Whereas this will affect and reduce the services previously available from the Engineering and Construction Department of Water Resources to rural municipalities; And Whereas rural municipalities may find it necessary to engage the services of alternate engineering and consulting firms to perform the services previously available from the Manitoba Water Resources Engineering and Construction Department; Therefore Be It Resolved that the Minister of Natural Resources of the Province of Manitoba consider and propose a uniform and consistent standard of "engineering and design standards" for the purpose of waterway construction within a said watershed.
