The Council of the Rural Municipality of Morris held its regular meeting at 10:00 A.M. on Thursday, October 10th, 1991 in the Council Chambers of the R. M. of Morris.

Reeve Dan Thiessen presided.  
Present were Councillors: George St. Hilaire, Harold Dyck, Bill Martens, Allan Dickson, Glenn Curdt, Dick Zacharias.

Minutes Moved by W. E. Martens, Seconded by George St. Hilaire:  
#234/91. Resolved that the minutes of the September 12, 1991 regular meeting be now adopted as presented.  
Carried.

Twin Rose Swine Culvert Moved by W. E. Martens, Seconded by D. Zacharias:  
#235/91. Whereas Twin Rose Swine Inc. has recently constructed a hog barn where they have requested a culvert installation through P.R. 523;  
And Whereas this culvert is for the purpose of filling with water their water reservoir for hte barn;  
Therefore Be It Resolved that the Rural Municipality of Morris has no objections to the installation of this culvert through P.R. 523 at the location immediately south of their water reservoirs.

And Whereas the Rural Municipality of Morris received no prior advisement to this decision;  
And Whereas the Rural Municipality of Morris is not in favor of this transfer of Provincial Roads;  
Therefore Be It Resolved that the Rural Municipality of Morris opposes this transfer of roads and now gives notice that the Rural Municipality of Morris will not be accepting these roads from the Province of Manitoba.

And further Be It Resolved that all future costs involving this particular drain, including work and materials, shall be cost shared on a 50/50 basis between the R. M. of Morris and the R. M. of Montcalm.

And Whereas Council believes that these lease payments are towards the Capital purchase of this machine and therefore, these funds should be expended from the Machinery Replacement Reserve Fund;

And Whereas for 1991, the Rural Municipality of Morris will be making these lease payments totally \$27,930.00;

Therefore Be It resolved that the Rural Municipality of Morris request approval from the Minister of Rural Development to withdraw \$27,930.00 from our Machinery Replacement Reserve for the purpose of contributing towards the purchase of a Caterpillar D-6H crawler.

#252/91. Whereas Canadian farmers are facing an extreme cash shortage due to the lowering of wheat prices to the \$2.00 per bushel range;


And Whereas the current low price and wheat is due to an international trade war on wheat and not the fault of the Canadian farmer;
