Foreman Report Mr. Don Harder, Public Works Foreman, then met with Council. He mentioned that the road gravelling is done to the S of the SW of Section 16-6-1 WPM to the hog barn and also to Kames's trailer to the S. of the SW of Section 27-6-1 EPM and that the owners are responsible for paying for this gravel. On the matter of the bridge in the SE corner of Section 33-5-1 WPM, it was recently damaged and rather then repair the bridge it was felt by Council that a low level crossing should be installed. Mr. Harder indicated that 3 - 36" culverts would be needed, however, this bridge is on a ditch cost shared with the R. M. of Roland and they need to be notified of this happening. It is estimated that the cost of the project including culverts, riprap, geotextile, etc. would be approximately \$5,000.00 to \$6,000.00.

For the Sperling Landfill Site, a building is needed and there is a building at the Rosenort Landfill Site which could be moved to Sperling.

Red River Community College G.I.S. work request Council then met with Mr. Dave Woytowich, Mr. Bruce Goulsbra and Mr. Rob Zakaluk from Red River Community College. Mr. Woytowich explained that they are instructors at Red River Community College and they are trying to arrange work with Municipalities for their students in the G.P.S. field. Having the students do GPS work gives the students field work experience and also helps the Municipality by providing this information findings.

Mr. Bruce Boulsbra stated that the Geographic Information System obtained by the GPS findings would eventually provide elevation information to any spot. The Federal Government is interested in having this information done, however, it may take many years to have this information available for southern Manitoba. This G.I.S. information is both vertical and horizontal information.

Mr. Woytowich explained that the cost to the Municipality would be \$5,000.00 which is a subsidized cost and that this would provide information for a Township area. The elevation of roads, culverts, ditches, etc. would be done at every mile corner and also on the ½ mile line. It would give a cross section (3D) picture for each area.

Mr. Rob Zakaluk mentioned that there were a number of mapping programs that this information could be used with. Their students are expected back by the end of October, 2000 and that they would do the work in the fall and over the winter months they would put the project together and the finished product for the Municipality would be ready by spring.

Council then recessed for lunch at 12:05 p.m. and reconvened at approximately 1:05 p.m.

Foreman Report Mr. Don Harder then met with Council again to discuss the Marsh River project where the bridge East of Section 12-5-2 EPM needs to be replaced. The decision of Council was that culverts be installed in place of the bridge. Council was informed that MEMO will not contribute for the bypass highwater route but will contribute only to the bridge structure replacement.

Therefore, the project will have to concentrate on the structure itself. As this claim is with the R. M. of De Salaberry, they are required to undertake the project and the work involved. Therefore, there is still some coordinating of work to be done on the situation.

Mr. Harder requested Council to consider purchasing a rome disc for the municipality as there would be a use for rome disc in the Municipality. There is one for sale with Cambrian Equipment for \$3,900.00 and he asked Council to consider this disc.

Councillor Ralph Groening informed Council that based on the drainage requests submitted to date, there is enough work for our 2001 drainage program.

Therefore Be It Resolved that the Rural Municipality of Morris requests that the Provincial Government, Department of Conservation be solicited to immediately reinstate capital infrastructure funding to a minimum of the 1990/1991 level for drainage projects required in the Province;

And further Be It Resolved that the Department of Conservation also be requested to prepare and make available to all municipalities their long range program and projections regarding drainage works.
