Department of Education re condition of road west of Rm 29-4-2W. this was left in the care of Councillor Braum.

Several replies were received in answer to letters sent out regarding silt etc in Drainage ditches

The matter of cleaning out same was discussed and the reply stated he would take the matter up with the Director of Public Works
An application for Old Age pension was received from Mrs Rosalie Bohm after discussion the following resolution was passed
