Mr Gauthier interviewed the Council regarding wood on road allowance between lots 351, 353 he stated that he had cut about 4 cords before the line was run showing boundary of his land he offered to buy the south half of the road allowance adjoining his land for 20.⁰⁰ after a discussion the following motion was passed.

That this Council will not furnish seed or feed grain to any party, whose land has been sold for arrears of taxes during the past two years and said land having never been redeemed from such sale, and further no feed grain shall be furnished to any party who at the present time is indebted to the Municipality for feed furnished by the Municipality at some previous date. (Carried)
