

Morris, Man. January 7th. 1936.

The first meeting of the Council for the year 1936 was held on the above date, the Council assembled at 11 A.M. and Reeve Churchill and Councillor Thiesen took the oath of Office, Councillor's McDonald and Gehring being absent.

The minutes of last regular meeting held December 20th were read and declared adopted as read.

By-Law No. 563 was read a first time;  
Moved by Councillor Thiesen,  
Seconded by Councillor Snarr,

That by-law No. 565 being a by-law for the purpose of fixing date, and place of meetings, for the year 1936, having been read the first time be now considered as having been read the second and third time and passed and the Reeve and Clerk be authorized to sign ~~them~~ and seal the same.

On motion of Councillor Snarr and Clubb the salary of the Municipal Clerk for the year 1936 was set at \$1700.00.

By-Law No. 564 was then read a first time,

By-Law No. 565 was then read a first time.

That by-law No. 565 being a by-law for the purpose of confirming the appointment of Secretary Treasurer for the year 1936, having been read the first time be now considered as having been read the second and third time and passed and the Reeve and Clerk be authorized to sign and seal the same. ( Carried)

The Council now adjourned to meet at 1.30 P.M.

Council reassembled at 1.30 Councillor McDonald arrived and took his seat at the table

Applications for the position of Solicitor were received from Messrs Slater and Moore after a discussion it was moved by Councillor McDonald,

Seconded by Councillor Snarr,

That William Moore be appointed Solicitor for the Rural Municipality of Morris for the year 1936. ( Carried)

The appointment of Health Officer's for the year 1936 was discussed and the following resolution passed,

That Dr. Arkin and Dr. Jamieson be appointed Health ~~officer~~ Officer's for the year 1936, Dr. Arkin for Wards 1.2.3.4.and 5. and Dr. Jamieson for Ward Six, at the following salaries, Dr. Arkin \$200.00 Dr. Jamieson \$50.00^ Health Officers to furnish own transportation free of charge. ( Carried)

Application for old age pension was received from John Flemur of DeWet, Man.

Moved by Councillor Clubb,  
Seconded by Councillor Stevenson,

That the application of John Flemur of DeWet for old age pension be recommended by this Council, ( carried)

Moved by Councillor Thiesen,  
Seconded by Councillor McDonald,

That Reeve Churchill and W.N.Stevenson be authorized to sign all cheques, bills of exchange, promissory notes ect, on behalf of the Municipality. ( Carried)

Seconded by Councillor McDonald,

That T.K.Bestwick be appointed as ~~assessor~~ assessor for the Rural Municipality of Morris for the year 1936. (carried)
