That the Clerk be instructed to call for Tenders on the following work, that is to say, the scrapeing. &painting of the Union - Point Ferry, tenders to be in by February 21st. at 12 oclock noon. (Carried)

Moved by Councillor Thiesen,

Seconded by Councillor Thiesen,

That the Clerk be instructed to call for applications for the position of Ferry-Men for Silver Plains and Union-Point Ferries season of 1936, applicants to state salary expected, and applications to be in by February 27th. (Carried)

Communications were received from L.A. Slater in connection of the drainage cases that were pending, and stating that same were been withdrawn,

also Secretary of the Drainage Commission giving date of meeting that the Committee from the Council were to meet the Commission, the above communications were discussed and ordered filed.

A letter was received from A. Flemur in connection with his father who was in St. Boniface Hospital.

A number of applications for relief were received and passed on by the

Council.

Bills and accounts were handed to the finance Committe the Finance Committee reported that the Treasurer is hereby authorized to pay the accounts as per list.
