(Carried)

Mr. Wells also asked for a grant and after a discussion the following resolution was passed,

That a grant of \$80.00 be given to the Canadian

Institute for the blind,

Carried.

In regard to the formation of the proposed School District east of the River the following resolution was passed,

Moved by Councillor Snarr, Seconded by Councillor McDonald.

That Mr. James Clubb be appointed as Arbitrator in connection with the application for a new School district situated on the east

side of Red River. ( Carried)
Mr. A.H. Wiebe petitioned the Council asking that the N.W. 26-4-1W be taken from the Heibert School District and added to the St. Peters School District.

Moved by Councillor Sparr,

Seconded by Councillor Thiessen,

That the petition presented by A.H. Wiebe be accepted by this Council and that the Clerk be instructed to prepare the necessary by-laws and notify those interested in the different districts. ( Carried)

Moved by Councillor Stevenson, Seconded by Councillor Clubb,

That t is Council adopt the Electors Roll of 1935 as the Electors Roll for 1936, and that the Council meet as a court of revision on the last Wednesday in August to make the necessary changes in same, ( Carried)

Mr. P.M. Friesen asked the Council for the advance of seed, as he was farming land that the following resolution was passed Moved by Councillor Gehring,

Seconded by Councillor Clubb,

That this Council supply P.M. Friesen with the follow. ing seed, namely 70 bushels wheat, 50 bushels barrier oats and 40 bushels flax. carried.)

Mr. C.A. Spaulding spoke to the Council in connection with a family who have been on relief and have resided in his farm buildings for a considerable period with out remaining any rent being paid, he thought that the Council should reimburse him to a certain extent, after a discussuion the following resolution was passed Moved by Councillor Gehring,

Seconded by Councillor Thiesen,

That C.A. Spaulding be paid \$5.00 per month rent on house occupied by I.D. Unrau, rent to be paid from January 1st. 1936.

An application was received from Mr. Slater on behalf of a client asking for a refund in connection with the penalties added to a tax sale property also another application in connection with the C.J.Lowen property, after a discussion by the Council the following resolution was passed.

Moved by Councillor Clubb,

Seconded by Councillor Snarr,

That no refund be made in connection with taxes re.

C.J. Loewen property and West half of Section 20-4-1 mast ( Carried)

The question of furnishing relief was discussed and the following resolution was passed,

Moved by Councillor Snarr, Seconded by Councillor Stevenson,

That Relief be discontinued after today April 17th

(carried) 1936.

The suestion of purchasing a larger drag for the dragging outfit was taken up and the following resolution was passed,

Moved by Councillor Clubb. Moved by Councillor Gehring,

That this Council order a number 40.

Richardson 12 foot drag for Municipal outfit. -

( carried)

Several communications were received and after a discussion

were ordered filed.

An enquiry was reveived from Dufferin Municipality asking for a report of the decision of the Morris Council in connection with the demage suit of Dufferin Tunicipality,

The Clerk was instructed to advise Dufferin Municipality that as Morris Municipality had a damage suit of their own to lock after, they would not be in a position to give any assistance to Dufferin.

Bills and accounts were presented to the finace Committee, the Finance Committee reported the Treasurer is hereby authorized to pay the accounts as per list. Moved by Councillor Gehring,

Noved by Councillor Genting,
Seconded by Councillor Thiessen,

That the report of the finance Committee be accepted and the Reeve and Clerk be authorized to issue cherues for the several amounts,

( Carried)

On motion the meeting then adjourned.
