That by-law No. 590 being a by-law for the purpose of classifying its highways under its jurisdiction as B. Highway's, having been read the first time be now considered as having been read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal the same. (Carried)

Bills and accounts were handed to the finance Committee, the Finance Committee reported the Treasurer is hereby authorized to pay the accounts as per list.
