Mr. R. H. Lewis appeared before the Council in connection with his

tenant Mr. Groff, he stated that he was unable to colect any rent from him and asked the Council to have him removed from the premises.

The Council stated he was not on relief at the present, consequently was not a charge of the Municipality. Mr. Lewis also asked for a culvert on his road which was promised him.

Owing to being necessary to hold Court of Revision on the next Council meeting it was necessary to postpone the date of the meeting one week, and the following resolution was passed.

Bills and Accounts were handed the finance Committee, the Committee reported the Treasurer is hereby authorized to pay the accounts as per list.
