Two delegations from Lowe Farm interviewed the Council in connection with sidewalks, after a discussion the following resolution was passed.

That this Council construct a gravel sidewalk for a distance of 300 feet between Block two and three and South of Blocks One and Two Lowe Farm. Carried.

P. H. Penner interviewed the Council in connection with the deepening of a ditch, Councillor Thiessen was instructed to look after the work.

A communication was received from Messrs. Bernier & Bernier in connection with a house on the road allowance, said road allowance being rented by Mr. Gauthier of St. Agathe. Councillor McDonald was instructed to deal with the subject.

A communication was received from the Goodyear Tire and Rubber Co. in connection with the sale of the used tires taken from the Municipal Tractor, the Company advised that they had an offer of \$80.00 for same. The Council advised the

Clerk to notify the Company that they would accept the offer. >
The question of securing piling for bridge purposes was discussed and the following resolution was passed.

prices on piling. Carried.

By-Law No. 594 was read a forst time. Moved by Councillor McDonald,

That by law No. 594 being a by-law for the purpose of nominating and electing a Reeve and three Councillors for the years 1938 second and third time and passed, and the Reeve and Clerk be authorized to sign and seal the same. Carried.

That our next regular meeting date be changed from November 19th to November 20th due to November 19th being the day of Municipal Elections. Carried.

Bills and accounts were handed the finance Committee, the Finance Committee reported the Treasurer is hereby authorized to pay the accounts as per list.

Moved by Councillor McDonald,

Moved by Councillor Thiessen,

That the report of the Finance Committee be accepted and the Reeve and Clerk be authorized to issue cheques for the several mounts. Carried.

The meeting then adjourned.
