A communication was received from Messrs. Kennedy & Kennedy in connection with the  $S_2^1$  and the NW $_2^1$  of Section 20-5-1W.

Moved by Councillor Spalding, Seconded by Councillor Griffiths,

That this Council accept proposition of Messrs. Kennedy & Kennedy re their client re  $S_{\frac{1}{2}}$  and  $NW_{\frac{1}{4}}$  Sec. 20-5-1W by repayment of 1932 Tax Sale and subsequent taxes of \$245.35. Carried.

A communication was received from the Minister of Public Works. Hon. W. R.

Clubb in connection with road east of Red River Bridge.

A letter in connection with Mothers Allowance application was read from Mrs. Julia Regitnig asking the Council to recommend same, the Council was agreeable. A communication was read from Messrs. Osler, Hammond & Nanton, agents for the North of Scotland Mortgage Co., in connection with the SE 11-4-2W. That the report of the Finance Committee be accepted and that the Reeve and Clerk issued cheques for the several amounts. on motion the Council adjourned to meet May 20th.
