the rate bylaw read a first time.

The question of the levying of a business tax for the year 1939 was discussed and the Council were not in favor of same, and the following resolution was passed.

A request for clothing from Scott family was granted.

Bills and accounts were handed to the finance Committee, the Finance Committee reported that the Treasurer is hereby authorized to pay the accounts as per list.

That the report of the Finance Committee
be accepted and the Reeve and Clerk be authorized to sign and issue cheques for the several amounts. Carried.

An application for old age pension was received from Mrs. Elsie Curdt of Sperling.

That the application of Mrs. Elsie Curdt of Sperling for old Age Pension be recommended to commence March 1st, 1959. Carried. The meeting then adjourned to meet March 17th, 1939.
