A regular meeting of the Council was held on the above date, Reeve Heppner and all the Councillors being present.

The minutes of regular meeting held June 16th, and special meetings held June 29th and July 20th, were read and declared adopted as read.

Several communications were read in connection with relief matters etc.. and were referred to the committee.

A petition was received from Messrs. Martens, Schmidt etal, asking for the formation of a new School District from land to be taken from Lone Star, Neufeld, Pleasant Valley and Tremont.

Seconded by Councillor Spalding,

That the petition of Messrs. Martens Schmidt etal, asking for a new School District be received and the Clerk notify all parties concerned in districts effected, to appear at the August regular meeting of the Council. Carried.

Mr. Mussinon of Aubigny appeared before the Council on behalf of the Ste Agathe Agricultural Society asking for a grant to same, as a great many of the Exhibitors at said KKKI fair were from the Morris Municipality.

Moved By Councillor McDonald,

Moved By Councillor Stevenson,

Seconded by Councillor Stevenson,

That a grant of Fifty Dollars be given the Ste Agathe Agricultural Society. Carried.

Applications for Old Age Pensions were received from Mrs. Rosie Bunkowsky and Elizabeth Dyck.

Moved by Councillor Stevenson, Seconded by Councillor Snarr,

That the applications of Mrs. Rosie Bunkowsky, Morris, Man., and Mrs. Elizabeth Dyck, Morris, Man. for Old Age Pension be recommended by this Council. Carried.

Councillor Marion of Montcalm Municipality spoke to the Council in connection with the proposed work on the Horse Shoe Lake road, he requested if the work was done that Montcalm Municipality be allowed to do the work with Morris Municipality paying one half the cost, the Morris Council were agreeable to this providing that Morris Municipality were allowed to put on six men and two Fresno with horses.

Mrs. Antonio Malo appeared before the Council asking that their family be recommended to the Social Service of Winnipeg on account of the condition of Mr. Malo, she stated she had her house clear of debt at Silver Plains. The Council decided if it was necessary for the family to receive relief the only place that they would furnish same would be in their own home at Silver Plains.

The condition of the road from Silver Plains station to the Highway was discussed and the following resolution passed, TATAL

That whereas the Provincial Gravel trucks have damaged the Highway leading from Silver Plains station to the Provincial Highway No. 14, by hauling gravel on same when road was wet.

Now therefor this Council are of the opinion that the Provincial Government should gravel this Highway and put same in as good a condition as when the trucks commenced to haul gravel over same. And that a copy of this resolution be forwarded to Mr. A. Beaubien, M.P. Carried.

By-Law No. 622 was read a first time. Moved by Councillor McDonald,

That By-Law No. 622 being a by-law for the purpose of opening a road across certain lots situated on the East side of the Red River, Parish of St. Agathe, and known as the St. Mary's Road, having been read the first time be now considered as having been read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal the same.

By-Law No. 623 was read the first time.

Moved by Councillor Griffiths, Seconded by Councillor Irvine,

That By-Law No. 623 being a by-law for the purpose of authorizing the sale of lots 4 and 5, Block 4, Plan 916 to John Dueck

Wiebe of the Village of Sperling, Laborer, having been read the first time be now considered as having been read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal the same. Carried.

By-Law No. 624 was read the first time.

Moved by Councillor Griffiths,

Seconded by Councillor Spalding,

That By-Law No. 624 being a By-Law to authorize the sale of Lots 23 and 24, Block 4, Plan 916, Village of Sperling to Rrederick Geswin, Laborer, having been read the first time be now considered as having been read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal the same. Carried.

Representatives from two culvert Companies interviewed the Council in connection with purchase of culverts, Council stated they were not in the market for any at present time.

Mr. C. L. Thring, Assessor, forwarded copies of changes in the Elector's Roll for each of the Councillors.

A communication was read from the Minister of Public Works in connection with the request for gravelling Trump Road, he stated that all allocations had already been made.

A communication was received from Dr. R. H. Lay stating that the portion of the Municipality East of the River had been declared a restricted area, and that the testing of the cattle would be proceeded with at once.

A communication was received from Mr. Chisholm in connection with weeds on grade between Section 5 and 676-1W. The Clerk was instructed to advise Mr. J. D. Penner that the Council would allow him \$8.00 per mile to level this portion.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported the Treasurer is hereby authorized to pay the accounts as per list.

Seconded by Councillor McDonald,

That the report of the Finance Committee be accepted and the Reeve and Clerk issue cheques for the several amounts. Carried.

The meeting then adjourned to meet on August 18th, at 1 P.M. when Court of Revision would be held in connection with Electors Roll.
