A list of Elevator Annex's and assessment of same were read, it was noted that one or two had been omitted, and the Clerk was instructed to advise the Assessor of same.

A letter was read from the Minister of Public Works in connection with estimate of cost of gravelling road East from Red River Bridge. After a discussion the following resolution was passed.

That this Council appoint the Reeve and Councillors Stevenson, McDonald and Spalding to interview the Montcalm Council in connection with Inter Municipal road work east of Morris Bridge to the Boundary.

A letter was received from the Salvation army in connection with War Auxillary Service Organization, the Council were in favor of giving a grant but decided to wait until further information was received from the Chairman, Mayor Andrews of Emerson.

an application was received from E. Coates for the position of Tractor

man for the Municipal Grading Engine, the application was placed on file.

A letter was received from the Secretary of the Weeds Commission in connection with the appointment of Inspector.

That each Douncillor be appointed Weed

Inspector in his own Ward for the year 1941. Carried.

A representative of the Richardson Road Machinery interviewed the Council, after a discussion the following resolution was passed.

Seconded by Councillor Stevenson,

That this Council order four Fresno from Richardson Road Machinery Co, with identification stamp of Wards thereon, also one No. 39 Drag for Ward Five. Carried.

The question of change of road at Sewell was taken up and the following resolution passed.

Moved by Councillor Davidson,

Seconded by Councillor Spalding,

That our Solicitor be authorized to make arrangements for right of way for change of Highway at Sewell. Carried.

Mr. MacMillan of the Rosseau Machinery Co. interviewed the Council in connection with the purchase of a dragging engine, he stated his Company had one at a price of \$2,000.00 about 33 horse power with Caterpillar tread. The Council decided to look into the subject by appointing a delegation to go to Winnipeg on March 28th to visit the different Companies which handled engines of this class.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Treasurer is hereby authorized to pay the accounts as per list.

Moved by Councillor Stevenson, Seconded by Councillor Davidson,

That the report of the Finance Committee be accepted and the Reeve and Clerk issue cheques for the several amounts. Carried.
