The Council met as a Court of Revision on the above date to revise the Electors Roll. The Reeve and all the Councillors being present, also the Assessor C. L. Thring. After the list had been recommended by the Councillors in their respective Wards and necessary changes recommended the following resolution passed.

That the Court of Revision in regard to the Electors Roll be closed and that the Electors as revised be the Electors Roll for the year 1941, and that the Clerk be instructed to have 100 copies of lists printed. Carried.

The Court of Revision was then closed and the Council met in regular

The minutes of former meeting were read and declared adopted as read. The resignation of the Assistant Secretary Mrs. A. Hubble was read, the Secretary explained that the services of Miss B. Jerome had been secured, the following resolution was then passed.

Seconded by Councillor Griffiths,

That this Council accept the resignation of Mrs. A. Hubble and that Miss Bella Jerome be engaged as Assistant to the Clerk at a salary of \$45.00 per month. Carried.

A discussion took place in connection with the Tender of E. Mousseau regarding the placing of guard rail at Bridge, it was decided to increase the amount and the following resolution was passed.

Moved by Councillor Davidson,

Seconded by Councillor Davidson,

That the Tender of E. Mousseau for building fence at Steel Bridge be raised from #35.00 to \$60.00.Carried.

The matter of signs at ferries was discussed and the following resolution passed.

Moved by Councillor McDonald, Seconded by Councillor Stevenson,

That the Clerk be authorized to order four danger signs to be placed at the two ferries Union Point and Silver Plains. Carried.

A request was received from St. Agathe Agricultural Society asking for a grant.

Moved by Councillor McDonald. Seconded by Councillor Stevenson,

That this Council give a grant of \$50.00 to the St. Agathe Agricultural Society. Carried.

Communications were received from the Department of Health in connection with Guenther and exeminations also Mrs. Malo and Mrs. Regetnig. It was decided to make a payment on relief for Mrs. Malo and Mrs. Regitnig and to write in connection with Mr. Guenther.

A letter was read in connection with Unemployment Insurance also from the Canada Ingot Iron Company re installing of culvert at Sperling.

A communication was read from W. J. Turner expressing his appreciation and thanks in connection with the part the Council took in regard to the passing away of his father.

A letter was received from Mr. Chisholm in regard to the deepening of a ditch East of the River. The matter was left in abeyance for the present.

A delegation consisting of Messrs. Saurette and Palud asked the Council to have a ditch deepened near their property. Councillor McDonald explained the situation in connection with same.

A delegation from Section 11 and 15 asked for the draining of the water from this district. The Council stated that nothing could be done this year.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported the Treasurer is hereby authorized to pay the accounts as per list.

That the report of the Finance Committee be accepted and the Reeve and Clerk be authorized to issue cheques for the several emounts. Carried.

The meeting then adjourned to meet August the 15th, 1941.
