That By-law No.657 being a By-law for the purpose of fixing rates and authorizing the collection of same, having been read the first time be now read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal same. Carried.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Clerk be authorized to pay the accounts as per list.

The the report of the Finance of the Committee be accepted and the Reeve and Clerk be authorized to issue cheques for the several accounts. Carried.

A letter was received from the Secretary of DeSalaberry Municipality in connection with the transfer of the East-half of the North-west of Section 19 Township 6 Range 3 East.from Union Point S. D. to Otterburne West S. D. The matter was left in abeyance until word was received from Union Point S.D.

Mr. C. L. Lount interviewed the Council in connection with the Purchase of culverts. The matter was left in abeyance for the present.

A Schedule of rates paid by McDonald Municipality was received for comparison with Morris Municipality rates. It is the intention of the Council to make further enquiries before any changes be made.

The meeting then adjourned to meet at 10.00 A. M. on Friday March 20th to make recommendations in connection with Feed Grain Notes and Hospital accounts.
