Morris, Manitoba. September 18th, 1942.

A regular meeting of the Council was held on the above date with all the members present except Councillor Davidson.

The minutes of the former meeting and Court of Revision in regard to the Elector's Roll were read and declared adopted as read.

Letters were read from the Solicitor, L. A. Slater, in connection with Lot 446, Sec. 8-6-1E. and the Sewell Road. Same were considered.

A communication was received from the Public Welfare Department Winnipeg, re Mrs. Reichert and Mrs. Juliette Malo. The first was left in abeyance, and the Clerk was instructed to hand over the Malo communication to rhe Solicitor for his advice.

Letters were received from the Department of Education re culverts at Flowery Bank School, also re condition of the road at J. H. Warkentine. The Reeve explained same would be taken care off.

A reply to the letter written the Canadian National Railways re condition of roads on Railway property at Kane and Lowe Farm was read. The Railway Company advised that they intend putting cinders on same.

A communication was received from the Canadian National Railways asking to be relieved of the maintenance of fencing Right-of-way on Lowe Farm-Kane Branch of Railway. The Council declined to grant the request.

The ferryman at Union Point, Alphonse Berthelette, wrote to the Council requesting that his salary be raised \$10.00 per month from last Spring and giving 7 days notice of resignation if the raise was refused.

Moved by Councillor Griffiths.

Moved by CouncillorSpalding,

That the resignation of Alphonse Berthelette, ferryman at Union Point be accepted as per letter of Sept. 9th.

The Clerk submitted a list of lands liable to be sold for arrears of taxes and the following resolution was passed: Moved by Councillor McDonald, Seconded by Councillor Stevenson,

That Whereas the Secretary-Treasurer has submitted a list of all lands within the Municipality so liable to be sold for arrears of taxes pursuant to the Statutes, and Whereas the Council desires that a sale of lands for taxes be held.

Now, Therefore, the Council directs the Reeve in his discretion to take all proper proceedings as required by Statute to collect said taxes by sale at the earliest possible moment. And further if for any reason sufficient buyers are not present at the sale to purchase the different parcels, the Resve is hereby authorized and instructed to purchase the said parcels in the name of the Rural Municipality of Morris. Carried.

Councillor McDonald explained to the Council that he had the chance of purchasing about 60 yards of gravel at \$1.00 per yard from H. Roy. After addiscussion the following resolution was passed:

Moved by Councillor Snarr, Seconded by Councillor Stevenson,

That Councillor McDonald be authorized to offer Hormidas Roy \$1.00 per yard for gravel he owns stored in Aubigny, said yardage not to exceed 70 yards. Carried.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Clerk be authorized to pay the accounts as per list. Moved by Councillor Stevenson,

Seconded by Councillor Snarr,

That the report of the Finance Committee be accepted and the Reeve and Clerk be authorized to issue cheques for the several amounts. Carried.

The meeting then adjourned to meet as a Court of Revision and regular meeting on Friday October 16th.
