A letter was received from the Solicitor, L. A. Slater, in connection with the expense of releasing that portion of Lot 446 not used for road purposes. The Council decided to pay the cost.

Mr. John D. Wiebe of Ste. Anne advised the Council that he would look after W. Wiley who is now in the Old Folk's Home for the same cost that is being paid the Home. The Council decided to leave Mr. Wiley in the Home as they thought it would be more satisfactory.

A letter was received from the Sperling Rink Company asking for a payment on account of the Rink Levy amounting to \$85.50. The Secretary was authorized to send this amount.

The resignation of Dr. Colert, Health Officer, was received but same was left in abeyance for the present.

A letter was received from the Powell Equipment Company stating that the Wartime Prices and Trade Board of Toronto had recommended the application for the purchase of D.6 Tractor and that the application had been forwarded to Ottawa with an application for same to be processed.

That this Council order two Drags from the Canada Ingot Iron Company for Ward Four. Carried.

A letter was received from the Manitoba Assessment Commission stating that the sanction of the Commission had been given to the adoption of the 1943 Assessment Roll as the 1944 Roll subject to the necessary changes.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Treasurer is hereby authorized to pay the accounts as per list.

Moved by Councillor Stevenson,

Moved by Councillor Davidson,

Seconded by Councillor Davidson,

That the report of the Finance for the severe Committee be accepted and the Reeve and Clerk issue cheques for the several amounts. Carried.

Mr. Hamilton, representative of the Canada Ingot Iron Company, interviewed the Council in connection with the sale of cement culverts, etc. Orders for several were given.

The meeting then adjourned to meet on Friday May 21st.
