Messrs. Penner and Esau appeared before the Council asking for a bonus on the season's work. The subject was laid over until next meeting.

The following resolution was passed in connection with the annual meeting of the Union of Manitoba Municipalities:

That this Council attend the Municipality Convention in a body and that Reeve Heppner be appointed official voting delegate, the actual expenses to be paid by the Municipality. Carried.

The price to be paid for land acquired for a roadway from Sec. 12-4-1W. was discussed and the following resolution passed:

Moved by Councillor Anderson,

Seconded by Councillor Davidson,

That Albert Recksiedler be paid \$30.00 per acre for land taken for right-of-way on Sec. 12-4-1W. Carried.

Mrs. Mousseau of Aubigny interviewed the Council in regard to maintenance grant which had been discontinued. The Council decided to hold same in abeyance for another month for investigation.

Mr. George Moody interviewed the Council in regard to a crossing on the Willox drain. The Reeve explained that same would be completed shortly.

A communication was received from the Child Welfare Department in connection with passing a by-law re Mrs. Neufeld who is residing in Montcalm Municipality. The Council decided that it would not be necessary to pass a by-law as she would be there only a short time.

Mr. Campbell, Agricultural Representative, discussed with the Council pre-war activities and projects and a general programme was outlined.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Treasurer is authorized to pay the accounts as per list.
