Morris, Manitoba. July 20th, 1945.

The Council met as a Court of Revision on the above date to revise the Elector's Roll. All members were present, also the assessor, C. L. Thring. A list of changes was recommended by the Councillors in their respective wards and the following resolution was passed:

Moved by Councillor Griffiths, Seconded by Councillor Davidson,

That the Court of Revision in regard to the Elector's Roll be closed and that the Elector's Roll as revised be the Elector's Roll for the year 1945, and the Clerk be instructed to have 100 comies printed. Carried. to have 100 copies printed. Carried.

The minutes of the former meeting held June 15th were read and declared adopted as read.

- L. G. Breyfogle of Union Point interviewed the Council and asked that the Municipality pay the sum of one dollar to the owner of each calf vaccinated against Bangs disease, said sum to be reimbursed by the Government. Reeve Heppner stated that the matter would be dealt with at the next meeting.
- A Committee consisting of B. McKenzie, J. H. Dickson and C. G. Covernton interviewed the Council and asked for a grant equal to that to be given by the Town of Morris towards the erection of a Memorial Hall. The matter was left in abeyance for the present.
- Mr. Slock of Aubigny asked the Council for a ditch across his land but the request could not be granted at the present time.
- Mr. Chisholm interviewed the Council in connection with the drainage on N.W. 34-4-1W. and the Clerk was instructed to write to the Canadian National Railway Company regarding same. He also asked for a culvert on S_2^1 11-5-1W. and was advised that the matter would receive attention.

A discussion took place in connection with drainage in Ward Four and the following resolution was passed:

Seconded by Councillor Thiessen,

That the Reeve and the Finance Committee interview the Deputy Minister of Public Works re financing the drainage in Ward Four. Carried.

Councillor McDonald asked that a grant of \$10.00 per month be given to Mrs. Rose Berthelette of Aubigny until her Old Age Pension application could be accepted by the Board. Councillor Thiessen also explained to the Council that D. A. Falk of Lowe Farm would keep his feeble minded son at home instead of having him sent to a Public Institution if the Municipality would give him \$10.00 per month

Moved by Councillor Thiessen,

Seconded by Councillor Thiessen,

That the Municipality of Morrise

That the give each to Mrs. Rose Berthelette and D. A. Falk, for his son Henry, \$10.00 per month. Carried.

A. J. Sawatzky asked the Council for their co-operation in getting a petition signed for a new hospital in the Town of Morris. Each Councillor agreed to assist in his own ward.

Jacob Penner notified the Council that unless his wagws were increased he would leave. After a discussion Councillor Thiessen was instructed to notify Mr. Penner that his request could not be granted.

A. D. Plett instrviewed the Council in connection with washout caused by water from the east cutting across the north-west portion of his land and asked for part of the road allowance in lieu of drainage. Reeve Heppner stated that Councillor Stevenson would attend to same.

Mr. McNamara of the Manitoba Power Commission was present at the meeting in connection with installing street lights in the village of Kane.

Moved by Councillor Interpolar,
Seconded by Councillor Griffiths,
That the Municipality of Morris agrees to have four one-hundred watt street lights installed in the Village of Kane, providing the Municipality of Roland pay one-quarter of the cost. Carried.

> Moved by Councillor Stevenson, Seconded by Councillor McDonald,

That Councillor Thiessen be appointed to the Altona Hospital Board to represent that portion of Wards One and The that is in the Altona Hospital Zone. Carried.

Councillor Griffiths asked for gravel to spread on the streets in Sperling.

Moved by Councillor Stevenson.

Seconded by Councillor Griffiths,

That the Secretary-Treasurer order 130 yards of gravel for the Village of Sperling, Carried.

The following resolution waspassed in connection with the Court House Committee:

Moved by Councillor Anderson,

That the present Court House Committee be suspended, and that Reeve Heppner and Councillor Steven son be appointed to said Committee and that the Secretary-Treasurer, O. T. Johnson be advised of same. Carried.

Bills and accounts were handed to the Finance Committee, the Finance Committee reported that the Treasurer is hereby authorized to pay the accounts as per list.

Moved by Councillor Griffiths,

Moved by Councillor Thiessen,

That the report of the Finance Committee be accepted and the Reeve and Clerk issue cheques for the several amounts. Carried.
