

Morris, Manitoba.  
June 21st, 1946.

A regular meeting was held by the Council of the Rural Municipality of Morris on the above date. All members being present, the Secretary read the Minutes of the last Meeting, which were adopted as being correct as read.

An Application from Peter P. Funk, for Old Age Pension was presented to the Council for consideration, and the following motion passed.

Moved by Councillor Thiessen.

Seconded by Councillor Anderson.

That the application of Peter P. Funk for old age pension be recommended by the Old Age Pensions Board for acceptance. Carried.

Moved by Councillor Anderson.

Seconded by Councillor Stevenson.

That a rental of 10 cents per working hour be given to P.A. Falk and P.A. Geisbrecht for use of their respective cars and trailers. Carried.

By-Law No. 704 was read the first time.

Moved by Councillor Davidson.

Seconded by Councillor Thiessen.

That By-Law No. 704 being a By-Law of the R.M. of Morris re. the Altona Hospital District be hereby considered as having been read the First and Second time on the 17th day of May 1946. Carried.

By-Law No. 705 was read the First time.

Moved by Councillor Stevenson.

Seconded by Councillor Anderson.

That By-Law No. 705 being a By-Law for the purpose of a money By-Law in the Rosenort School District No. 60, having been read the First time, be now considered as having been read the second and third time and passed, and the Reeve and Clerk be authorized to sign and seal same. Carried.

As the Village of Sperling wish to have another light added to its Street lights and a letter from the Manitoba Power Commission, asking for a copy of a resolution from the Council was presented, the following motion was passed.

Moved by Councillor Ribordy.

Seconded by Councillor Anderson.

That the Manitoba Power Commission be requested to place One Street-Light at the South West corner of Lot 25 Blk. 9 P. 916 in the Village of Sperling, The same wattage as other street lights in the Village of Sperling. Carried.

Moved by Councillor McDonald.

Seconded by Councillor Stevenson.

That the road on the West side of the East half of Section One-Four-One West be enlarged by 33 Feet on the East side of the present road. And that the Solicitor be instructed to make the necessary arrangements with the owners and have the plans made and filed. Price per Acre to be not more than \$50.00 per Acre. Carried.

Mr. E.A. McDonald & Mr. S. Robert waited on the Council with regard to a roadway on River Lot # 480 and were advised that a satisfactory arrangement could no doubt be made.

A delegation of 4 waited on the Council with regard to drains, and were advised that it would be looked into.



Bills and accounts were handed to the Finance Committee, who reported that the Treasurer be authorized to pay same as per list.

Moved by Councillor Ribordy.

Seconded by Councillor Thiessen.

That the Finance Report be accepted and the Reeve and Clerk be authorized to issue cheques for the several amounts. Carried.
