The Council of the Rural Municipality of Morris held its' regular meeting on the above date in the Court House Building. All members being present, the Secretary read the Minutes of the last Meeting, which were adopted as being correct.

Mr.Burnett waited on the Council with respect to drainage at his land and it was agreed that the R.M. of Dufferin should put a culvert at the N.E. of 12-6-3W.

Mr.Shewman waited on the Council with regard to a Grant to the Morris Agricultural Society. It was stated that the Morris Community Hospital wished a further Grant this year and a letter from the Morris W.I. was read re. a grant to help defray the expenses of entertaining the returned boys at a supper, and the following motions passed:

Stevenson - Thiessen:

That this Municipality give a Grant of \$250.00 to the A Morris Agricultural Society for the Year 1946. CARRIED.

Stevenson - McDonald:

That the Morris Womens' Institute be given a Grant of \$ 50.00 toward entertaining the returned men. CARRIED. Stevenson - Davidson:

That this Municipality give a Grant of \$ 300.00 to the Morris Community Hospital. CARRIED.

By-Law # 710 was read a First time.

Ribordy - Anderson:

That By-Law # 710 being a By-Law of this Municipality re. Carman Hospital District, be now considered as having had its' second reading and to be given its' Third reading aftervthe vote on the said By-Law if carried. CARRIED By-Law # 711 was read a first time.

Ribordy - Thiessen:

That By-Law # 711 being a By-Law for the purpose of raising \$561.26 from the proposed Carman hospital district yearly, and naming a polling place re. the said hospital district 20, having been read the First time be now considered as having been read the second and Third times and passed. And the Reeve and Clerk be hereby authorized to sign and seal same. CARRIED.

By-Law # 712 was read a First time.

Thiessen - Ribordy:

That By-Law # 712 being a By-Law of this Municipality for the purpose of authorizing the holding of Nominations for Councillors for Wards ne, Two & Four for the years 1947 & 1948 and if necessary an Election, having been read the First time, be now considered as having been read the second & Third times and hassed, and the Reeve and Clerk be hereby authorized to sign & seal same.CARRIED. Ribordy - Thiessen:

That Taxes on \$1,000.00 assessment of the personal property of the Monarch Lumber Co. at Sperling, now outstanding for 1946 be cancelled. CARRIED.

Davidson - Anderson:

That whereas the Secretary-Treasurer has submitted a ist of lands within the Municipality, so liable to be sold for arrears of Taxes, puruent to the Statutes and whereas the Council desires that a sale of lands for Taxes e held. Now therefore the Council directs the Reeve in his discretion to take all proper proceedings as required by statutes, to collect said Taxes by sale at the eariest possible date. And further, if for any reason, sufficient buyers are not present at the sale to purchase the different parcels, the Reeve is hereby authorized to purhase the said parcels in the name of the Rural Municipality of Morris. CARRIED.

Bills and accounts were handed to the Finance Committee, who reported that

he Treasurer be authorized to pay same as per list.

Thiessen - Ribordy:

That the Finance Report be accepted and the Reeve and lerk be authorized to issue cheques for the several amounts.CARRIED. The meeting then adjourned till Nov.lst, when the Council would sit as Court of Revision to consider appeals and revise the assessment roll for 1947.

On November 1st, the Council of the R.M. of Morris met in the Court House Building as a court of revision to hear appeals lodged against assessments and revise the assessment roll. Twenty-three appeals were dealt with as per appeal register. After reviewing all appeals and decisions made re. same, the following motions passed Stevenson - Anderson:

That the Court of Revision be now closed and the assessment roll for the year 1947, and the assessor make the necessary changes as authorized. CARRIED. McDonald - Ribordy:

That the list of changes of ownership as supplied by the assessor and supported by the Land Titles Offices be approved and the necessary changes in ownership be made in the records of the Municipality CARRIED.

The assessor and all the Council except Councillor Thiessen were present. The Meeting then adjourned till Nov.15th next.
