Whereas, it is deemed desirable to have X-Ray diagnost in facilities made available in the Carman Hospital at the earliest possible date under the provisions of "The Health Services Act", and whereas, it has been proposed by the Department of Health & Public Welfare that a local Health Unit and diagnostic unit be established under the provisions of "The Health Services Act" to include Twp. 6, Range 2W. of the Bural Municipality of Morris in the Carman Hospital District # 20. Therefore be it resolved that the Rural Municipality of Morris go on record of favoring this proposal and expressing its' willingness of the said Twp. 6, Range 2 W. to be included in such a local Health Unit and Diagnostic Unit, as and when such services can be made available.

Lowe Farm Pool Hall

Mr. Edward Braun of Lowe Farm, Man., made application to secure a license to operate a pool room in the Village of Lowe Farm. Then was also a statement signed by several residents of Lowe Farm, that they had no objection to a pool room being operated in Lowe Farm. Neufeld - Ribordy:

That the Clerk be authorized to have a BY/LAW drawn up governing pool-tables, licenses, atc. according to Sec. 37 of the Manicipal Act and the application of Edward Breun to operate a Pool and Billiard Hall in the Village of Lowe Farm be accepted, subject to make and regulations set down in the builder. rules and regulations set downz in the by-law.

More Street Lights in Sperling & Lowe Farm

Councillors Ribordy and Neufeld reported that more street lights were needed in the villages of Sperling and Lowe Farm.

Ribordy - Neufeld;
That the Manitoba Power Commission be requested to put a street light on the N.W. corner of N.Z of S.W. of 29-6-2W. in the Village of Sperling and also to put in the necessary street lights along the Western boundary of Plan 427, being a part of the Village of Lowe Farm. CARRIED.

Govt.Grant For Shannon Creek

A letter from the Department of Public Works was read, in which advise was given that a Grant of \$3,500.00 would be given,100% Government re-repairs to washouts and bridges in the Shannon Greek Floodway Twp.4, in Ranges 1 & 2 W.

Salvation Army

Major Flannigan met the Council with regard to a Grant to the Worthy Cause of the Salvation Army. Annual Nomination Meeting

The annual Nomination Meeting was held in the Court House at Morris on October 12th, at the hour of 2:00 P. M. The Secretary read the nominations which were as follows:- R. S. Davidson acclaimed Councillor for Ward One for the years 1949 and 1950; Bruce MacKenzie acclaimed Councillor for Ward Two for 1949 and 1950; and A. Collette acclaimed Councillor for Ward Four for 1949 and 1950.

By motion of Messrs. Moody and Stevenson, Mr. Ed. Snarr was chairman of the meeting and very ably performed that duty. Each sitting Councillor was called in turn to give account of work done in his respective ward and the money he had spent on same. All Councillors present having given a satisfactory report, Reeve Heppner reported for H. H. Anderson who was unable to be present. The Reeve was then called on to outline the work and programme of the Municipality and explain the September Financial Statement. Next to be called on was Bruce Mackenzie who assured those present that he would fill the office of Councillor to the best of his ability. He highly commended the work done by the retiring Councillor, Mr. Anderson.

Some discussion took place with regard to Grasshopper and weeds control, etc. As the grasshopper situation seemed to indicate a need for control next season, it was hoped that the Dept. of Agriculture would be supplying poison for spraying if needed.

Those present seemed to be satisfied with the progress of the

Municipality.
