Levy for Morris Hospital Dist.# 25, to be

A letter from the Morris Hospital District # 25, in which we were advised that only the amount of \$3,965.15 would be necessary to be levied for the District this year in the R.M.of Morris, as they were only borrowing \$190.000.00 instead of \$3,965.15 for/49 \$250.000.00, was read.

> A letter from P.H.Braun of Lowe Farm was read, in which assistance was asked for for Mrs.C.K.Gerbrandt of Lowe Farm until her blind pension would be forthcomming. It was decided that Councillor Neufeld would investigate and make any necessary arrangements.

A letter from the Dept.of Health & Public Welfare was read, in which assistance was asked for for Mrs. Anne Neufeld of Arnaud, Man., as the Mothers' allowance had ceased due to her youngest child becoming the age of 15 years. It was decided to leave the matter in abeyance.

A Letter from J.R.Giesbrecht of Lowe Farm, was read in which he asked that this Municipality pay the belance of his hospital accounts, that he was unable at this time to pay them. It was decided that the Council was not in a position to pay the accounts and that Mr.Giesbrecht should be making arrangements with the hospitals to pay them direct himself.
