A letter from the Manitoba Federation of Agriculture and Co-operation was read, in which we were again asked to give permission to them to conduct a tageday in this Municipality on Saturday, June 18th, 1949.

That the Manitoba Federation of Agriculture and Co-op eration be given the right to hold a tag-day in this Municipality on June 19th, 1949. CARRIED.

An application for admission of F.R.Gratton of Union Point to the Hospice Tache, was presented to the Council for consideration.

Stevenson - Collette;

That Reeve Heppner be authorized to sign the application of the control o ation for admittance of F.R.Gratton of Union Point to the Hospice Teche.

A letter from the Youny Womens'Christian Association was read, in which a grant toward their building fund was asked. Stevenson - Collette;

That the Young Womens' Christian Association be given

Reeve Heppner was unable to attend the meeting in the afternoon, due to having to go to Winnipeg to attend another meeting, it was therefore necessary to appoint an acting Reeve for the remainder of the meeting.

Neufeld - Davidson;
That Councillor Stevenson be Acting Reeve for the remainder of the year 1949 and be authorized to sign all cheques, resolutions and lists of accounts. CARRIED.

Collette - Davidson;
That the Clerk be instructed to write Mr.Cameron of To have the U.P. That the Clerk be instructed to write Mr. Cameron of ferry inspected. the Dept. of Public Works, requesting him to have the ferry at Union Point inspected. CARRIED.

> Mr.Bunkowsky attended at the meeting with regard to some bridges that were in need of repair, he was advised they would be attended to as soon as possible. Mr.E.Bunkowsky attended at the meeting with regard to dirt which had drifted into the ditch by his farm, he was advised that the matter would be looked into.

> A delegation of Reeves and Council members of the three Municipalities to the east of us, and headed by Reeve Johnson of De.Salaberry, met the Council with regard to the intermunicipal road between the R.M. of Morris and the R.M. of De. Salaberry and the R.M. of Montcalm and the R.M. of De. Salaberry, stating that some of the said road has been built and they wished an agreement on a programme to complete the building and gravel same. They were advised that no promise could be made until we knew the wish of the ratepayers of this municipality in Ward four.

A delegation of approximately 30 and Headed by Mr.McDonald of Aubigny, attended at the meeting with regard to having the St.Marys' road rebuilt and prepared for gravelling. They maximum were advised that Councillor Collette was in charge of any work done in his ward and would use his own judgement as to where he would build the roads therein.

Mr. Arkins asked about the intentions of the Council re. the Union Point ferry and miximum was advised that we had to have the ferry inspected before it could be used, that we had twice requested the inspection to be made, but to date it had not been done.

Communications.

The following communications were read and dealt with:-

A letter from the Morris Branch of the Canadian Legion, asking the Municipality to place a wreath at the cenotaph on June 19th, the Treasurer was asked to order a wreath for same and Councillor Stevenson was asked to place the wreath.

A letter from the Eastern Judicial District, advising that the District Convention would be held in Selkirk on Friday, June 24th, 1949.

A letter from the Canadian Oil Companies Ltd., edvising that they would accept our offer of \$100.00 for settlement of the demage claim to their sterage Tank and for loss of gasoline at Lowe Farm.

A letter from the Deputy Municipal Commissioner, Mr. Fisher, advising that Mr. Atkin had been in to see him re, the Union Point ferry and wax asked what our intention was with regard to same. The Clerk advised the Council that he had written Mr. Fisher in reply and advised him that we had wished the ferry inspected before puting it into the water for use.

A letter from the Highways Branch of the Dept.of Public Works, edvising that this Municipality would not be allowed 50% of the sunkafather cost of the bridge W.of 7-5-3E., as it was not included in the flood damage estimates for this Municipality.

Bills and accounts were handed to the Finance Committee, who reported that the Treasurer should be authorized to pay same as per list.

Ribordy - Neufeld;

That the accounts amounting to the sum of \$10,958.09,approved by the Finance Committee be passed, and the Reeve and Treasurer be hereby authorized to issue cheques for the several committee. amounts. CARRIED.
