Correspondencie

A letter from the Dept.of Agriculture was read, in which they advised that laying hens could be purchased from people whose names and addresses appeared on the list enclosed with their latter.

A letter from C.C.Peck was read in which he asked to be paid for damage to his cultivated land caused by people driving on it, also that he wished the horse-shoe lake road repaired and culverts installed. The Council thought there should have been a proper account made by Mr. Peck for damage done, if he wished to collect.

A letter from the Drainage Maintenance Boards was read, in which they stated that they would pay their share of unemployment insurance to us that we could place stamps in the workers' books and that the individual workers could paid pay their respective contributions direct to this office. It was decided that it would be much better if the Board would deduct the necessary amount from the workers and forward us a cheque for the full amount of the stamps and that we could purchase the stamps and effix same in the respective books. withink

A letter from Mrs. Dyck was read, in which she asked to be reimbursed for the cost of providing sleeping accomodation for Mrs. Thiessen & Family, Councillor Bavidson was asked to attend to same.

A letter from the Hospital Council of Manitoba was read, in which they advised that land could not be transferred from one hospital district to another.
