Minutes, The Council of the Rural Municipality of Morris met for the regular monthly meeting in the Court House in the Town of Morris on the above date. The Reeve declaring the meeting open, the Secretary read the minutes of the last meeting, which were adopted as being correct by motion of Councillors Stevenson and Collette. Carried.

Operators & Bridge workers to receive 10¢ per hr. more. Some machinery operators and Abe Kehler (bridge foreman) attended at the meeting and asked for a 10¢ per hr. raise in wages retroactive to July 1st, 1950, due to the higher cost of living etc. Neufeld - Collette; That the machinery operators and bridge builders wages be raised by 10¢ per hour, retroactive to July 1st, 1950. Carried.

Grant of \$100.00 to the Children's Aid Society. A letter from the Children's Aid Society of Central Manitoba was read, in which a grant from this Municipality was asked. Stevenson - Neufeld; That the Children's Aid Society of Central Manitoba be given a grant of \$100.00 for the year 1950. Carried.

\$22.00 deferred fees re. N.E. 19-5-1W. A letter from Messrs. Slater & Farrell was read, in which they advised that there were deferred fees amounting to \$22.00 re. the 1931 Tax Sale re. N.E. 19-5-1W., which taxes were subsequently consolidated, and suggested that this Municipality should pay the fees to clear the matter up. Neufeld - Davidson; That we pay the deferred fees amounting to \$22.00 re. the 1931 Tax Sale and consolidation re. N.E. 19-5-1W. Carried.

Bills & Accts. Bills and accounts were handed to the Finance Committee, who reported that the Treasurer should be authorized to pay same as per list. Ribordy - Neufeld; That the accounts amounting to the sum of \$13,751.26, approved by the Finance Committee be passed, and the Reeve and Treasurer be hereby authorized to issue cheques for the several amounts. Carried.

Gov. requested to place road signs. That the Manitoba Government be requested to place speed-limit signs in the Village of Lowe Farm on Highway No. 23. Also signs at the intersection of No. 75 Highway and the Aubigny-Rosenort road, showing the direction and distance to Aubigny, Silver Plains, McTavish and Rosenort. Carried.

Re. gravelling M.- D. road. That Councillor Collette be authorized to make the necessary arrangements with the R.M. of Montcalm, re. gravelling the Morris-Dufrost road. Carried.

Two cars of bridge timber. That the Municipality order two car-loads of bridge planks from the Drainage Maintenance Boards. Carried.

Correspondence. from A letter from the Inspector of Schools (J.A. Peterson) was read, in which the Council was advised that the road between Secs. 4 & 5 in Twp. 6, Range 2W. was not in very good condition and that John Penner informed him that at certain times of the year he found it difficult to get his child to Tremont School. Mr. Penner attended at the meeting with regard to this road. The matter was referred to Councillor Ribordy.

Inspector of Schools re. a road. A letter from the Municipal Commissioner was read, in which he advised that as far as he had any power or authority under Section "501" of "The Municipal Act", that he consented to the discontinuance of the Union Point Ferry, on the condition that the R.M. of Morris raise the grade and gravel St. Mary's road from Aubigny north to the northern boundary of the Municipality.

Dept. of Pub. works re. grants. A letter from the Dept. of Public Works was read, in which they advised that the following grants on a 50/50 basis were authorized:

J.F. Goossen re. bridge. A letter from Jacob F. Goossen was read, in which he advised that the bridge that spans the Morris river one mile south of Rosenort was in much need of repair. Mr. Mueller & Mr. Mazur attended at the meeting re. a survey for drainage which was being made on Mr. Muellers' farm, he was advised that it was only a survey for land slope that was being made at this time.

Delegations. Mr. Ritz of Sewell, attended at the meeting and asked that a bridge be placed at his lane for an approach to his property. Mousseau Bros. of Aubigny attended at the meeting with regard to damage done to their property by taking dirt from it for the ferry road, and finally agreed to accept \$300.00 for same.

The meeting then adjourned, next meeting to be held in the Court House at Morris on Friday, Oct. 13th, commencing at 10.00 O'Clock in the forenoon.
