A letter from the Manitoba Power Commission was read, in which they CARRIED.

pointed out that we were duty bound to pay the account re, removal and replacement of anchors in the amount of \$7.01. It was decided to pay the account.

A letter from Kane Equipment Co.was read, in which they advised that s school would be held at their plant in which instruction as to their line of machinery would be given and asked anyone interrested to attend, on Oct. 17th, /51.

Messre.B.E.Rempel and Johnny Dueck attended at the meeting, Mr.Rempel asked to have his gravel contract cancelled and Johnny Dueck advised that he would be willing to finish the gravelling providing he would get the job at his tender. It was decided that we should ask them to finish the job between them and that we should offer them \$2.75 per yard for same.
