That we purchase one two-wheel trailer from Henry Hildebrand, Lowe Farm, for the sum of \$50.00.

Blind Pers. Bunkowsky-Stevenson: That we recommend to the Blind Persons' Allowance Board, E. Loewen Winnipeg, the application of Mrs. Elizabeth Loewen, Rosenort.

Valcourt, St Jean @ \$2.85 a yd.(2.25 Aubigny-Rosenort to Johnny Dueck, Morris 42.50 a yd; also Sewell-Morris and Lowe Farm-Rosenfeld roads with 900 yds on each road @ \$2.50 a yd. Sperling-Kane Road to Charles A. Main, Carman, 35.35 a yd from Wood Pit.
