Recksiedler-Stevenson: That we appoint D. Heppner of Lowe Farm, as arbitrator re petition of L.L.Duvenaud et al, praying for the transfer Tremont S.D. of NW 10-6-2W from Tremont S.D. #1127 and adding same to the Consolidated School District of Sperling #1488. Carried

Road Gravel Kronsweide School

Neufeld-Bunkowsky: That we gravel the road from Lowe Farm to Kronsweide School, 32 miles, Lowe Farm to with approximately 300 yds of gravel per mile. Cost of said gravelling to be on a Ward-ratepayer basis. Ward 5 to share up to \$1,000. out of its appropriation. Work to commence when ratepayers pay their share of monies as per agreement with Councillor of Ward 5. Carried.

Sewell to Dewet School gravelling Recksiedler-Stevenson: That we gravel the road from Sewell to DeWet School, $\frac{1}{4}$ mile, with 300 yds per mile, Cost of said gravelling to be on Ward-ratepayer basis. Ward 1 to share half the cost of gravelling. Work to commence when ratepayers pay their share of monies as per agreement with Councillor of Ward 1.

Aid re J.F.Braun Lowe Farm Neufeld-Bunkowsky: That we grant J.F.Braun aid of \$50.00 per month and cheque to be payable to Mrs. Mary F. Braun; payment to be retroactive to July 1st, 1953. Carried.

Accounts

That Neufeld-Saurette: That the accounts approved by the Finance Committee be passed, and the Reeve and Secretary-Treasurer be hereby authorized to issue cheques for the several amounts.

Tax Arrears The Tax Arrears situation was discussed and it was decided to notify all parties in arrears for more than 2 years, requesting payment, in order to avoid selling their property on Tax Sale. Garried

Petition Brunkild-Lowe Farm Road

A petition was presented to Council by Gordon Last et al, re regrading and gravelling the Brunkild-Lowe Farm road. Consideration for this program will be given in the 1954 season.
