Nomination Day - October 13th

A meeting of the electors for the nomination of candidates for Reeve and Councillors for 1954-1955 term was held at 2:01 p.m. in the Court House Building at Morris, Man. 35 electors attended.

The Returning Officer read the nominations, declaring the Reeve, B.MacKenzie, and Councillors O.Bunkowsky of Ward 3 and M.Ribordy of Ward 6, elected by acclamation. Ward 5 nominees were: C.J.Neufeld, B.W.Thiessen and P.H.Penner.

Upon motion of 0. Bunkowsky and J.M.McDonald: M.J.Stevenson was appointed chairman of the meeting. He called upon each Councillor to give a report on work done and monies expended thus far. The reports made, showed the expenditures for culverts, gravelling, road maintenance, etc.

Reeve MacKenzie thanked the & electors for their support and the acclemation given him as Reeve for another 2 years. He read and explained the financial statement, comparing the financial position of the Municipality as of two years ago. He outlined the road program as to grading and gravelling; the bridge construction and the machinery purchases made during that time, which reflected healthy expenditures for necessary projects. He also reported on the work done by the Drainage Maintenance Board amd his duties as trustee of this Board.

General discussion followed, touching on subjects of local drainage, control of tree planting, higher remuneration for Reeve & Councillors, etc.
