- Inaugural Meeting The inaugural meeting of The Rural Municipality of Morris was held in the Court House Building on the above date. The oath of office was taken by the re-elected Councillors: W. F. Recksiedler and W.F.Schellenberg and by the newly elected Councillor B.W.Thiessen (Ed.Saurette), after which the meeting was declared opened. The minutes of the inaugural meeting held January 3, 1956 were read and adopted upon motion of W.F.Schellenberg and Otto Bunkowsky.
- By-Law 837 Office Salaries W. Recksiedler - B.W.Thiessen: That By-Law No. 837 being a By-Law for the purpose of fixing the salary of the Secretary and Assistant Secretary-Treasurer having been read a first time, be now considered as having been read a second and third time and passed and the Reeve and Sec.-Treasurer are hereby authorized to sign and seal same. Carried
- By-Law 838 Council Meetings Recksiedler-Ribordy: That By-Law No. 838 being a By-Law for the purpose of fixing the time and place of meetings of the Council and the indemnity for same, for the year 1957, having been read a first time, be now considered as having been read a second and third time and passed and the Reeve and Sec.-Treasurer are hereby authorized to sign and seal same. Carried
- Dep.Reeve W.Schellenberg-M.Ribordy: That we appoint OTTO BUNKOWSKY as DEPUTY REEVE of the Municipality for 1957. Carried
- Committees for 1957 Ribordy-B.Thiessen: That the following committees be appointed for the year 1957 with the first named to be chairman of said committee:  
FINANCE COMMITTEE: O.BUNKOWSKY, W.F.SCHELLENBERG and M. RIBORDY.

PUBLIC WORKS COMMITTEE: W.F.RECKSIEDLER, ED.SAURETTE and B.W.THIESSEN. Carried
- O.Bunkowsky-W.Schellenberg: That the following be appointed to the respective offices shown, for the year 1957:  
SOLICITORS: Slater & Farrell, Morris  
HEALTH OFFICER: Dr. J. C. Elias, Morris  
FERRY SUPERVISOR: Ed. Saurette, Aubigny  
Court House, Residence & Municipal Shed Committee: O.Bunkowsky & W.Recksiedler  
DRAINAGE TRUSTEES: C.J.Neufeld for Districts "V3", "V4" and "E".  
W.F.Recksiedler for District "G". Carried
- Saurette-Thiessen: That each Councillor be a committee of one in his ward re: Health, Relief and Fire Guardian. Carried
- House Rent O.Bunkowsky-W.Recksiedler: That the rental fee for the Municipal residence, occupied by the Secretary-Treasurer, be set at \$20.00 per month for the year 1957. Carried
- Renew Insurance Recksiedler-Schellenberg: That the Secretary-Treasurer be hereby authorized to have all Municipal Insurance coverage renewed for the year 1957. Carried
- Drain Survey River Lots 489 to 509 Ribordy-Bunkowsky: That we request the Drainage Maintenance Board to survey that portion of land extending from the Jenkins Drain south through River Lots No's. 509 to 489 connecting with the Roberts Drain, with a view to constructing a drain through same if found feasible to do so. Carried
