The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The meeting was opened by the Reeve after which the minutes of the May 10th Council session were read and adopted by motion of Otto Bunkowsky and Wm. Recksiedler.

Refund of \$125.90 to B. Kawjan

M. Ribordy-Otto Bunkowsky: That we refund the sum of \$125.00 to Bohdan Kasjan of Starbuck, being the purchase price paid by him for property described in CT 23845 and covered by By-Law No. 766, upon receipt of the above mentioned Title. Carried.

Water and Sewer Re Residence.

Wm. Schellenberg-Otto Bunkowsky: That we agree to install water and sewer services in the Municipal Residence.

No. 2 Dragline Oper. hired. M. Ribordy-Ed. Saurette: That we hire Carl Hruda of Morris, Manitoba. as operator of our No. 2 Dragline at \$300.00 per month retroactive to May 1, 1957.

Gravel Rates.W. F. Recksiedler-Wm. Schellenberg: That sale of gravel to individuals or corporations outside the limits of the R. M. of Morris be made at the price of \$1.25 a yard loaded.

Aid Re B.E. Heinrichs increased June-August

Wm. Recksiedler-Wm. Schellenberg: That the aid for B. E. Heinrichs of Morris be increased from \$25.00 a month to \$40.00 a month commencing June 1, 1957 and carried at this rate for July and August.

Wm. Recksiedler-Wm. Schellenberg: That the 1957 Electors Roll, having been advertised for 30 days and no written complaints received, be adopted and the Roll adopted Court of Revision regarding same be adjourned.

Sec.-Treas. Course.

W. F. Recksiedler-B. W. Thiessen: That the Secretary-Treasurer is hereby authorized to attend the Course in Municipal Administration from June 17th to June 21st and expenses re same be paid by the Municipality. It is also agreed that the office may remain closed during that time.

Penicillin Tablets for Rheumatic Fever.

Otto Bunkowsky-B. W. Thiessen: That Penicillin Tablets for control of Rheumatic Fever, as supplied by the Dept. of Health, be made available to resident cases of the municipality up to the age of 20 years. If this treatment is prescribed by a Medical Doctor, the cost will be cabried by the Municipality.

M. Ribordy-B. W. Thiessen: That the accounts as approved by the Finance Committee for \$24059.45 be approved and the Reeve and Secretary-Treasurer are hereby authorized to pay same.
