Minutes The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The meeting opened with the reading of the minutes of the December 13th session, which were adopted as read by motion of B.Thiessen and Ed. Saurette.

Bridge W.F.Schellenberg-O.Bunkowsky: That we call for tenders for No. 1  
Timber Fir Bridge Timbers, with the following specifications:  
Tender One-half carload of 3 x 12 - 18'  
One and one-half of 3 x 12 - 20'  
One carload of 3 x 12 - 24'  
Delivery to be made by March 31st and tenders to be in hands of the Secretary-Treasurer by January 22, 1958. Carried

Honorarium O.Bunkowsky-W.F.Schellenberg: That we pay W.F.Recksiedler,  
Drain.Trustee \$50.00 for services rendered as Drainage Trustee for Dis-  
trict "G" for 1957. Carried

Aid for B.Thiessen-W.Recksiedler: That we pay Mrs J.F.Braun \$55.00 aid  
J.F.Braun per month, on behalf of J.F.Braun, effective as of Jan. 1/58. Carried

Aid for B.Thiessen-M.Ribordy: That we pay Jacob B. Funk of Lowe Farm  
Jac B.Funk \$25.00 per month aid, commencing Jan. 1/58 and continuing to  
April 1st. Carried

Tobacco O. Bunkowsky-M.Ribordy:  
Watershed WHEREAS proper land use is prerequisite to conservation and  
water control in setting up a watershed district;  
organization AND WHEREAS considerable damage and public loss has occurred  
throughout the Tobacco Creek Watershed;  
AND WHEREAS the Tobacco Creek Watershed Committee, which has  
studied the problem for some time, has recommended the creation  
of an organization and authority to:  
1. Obtain a technical appraisal of required remedial works;  
2. Decide on works which should be undertaken in the public interest;  
3. Raise funds as may be required from time to time to undertake  
the works by levy against the lands to benefit;  
4. Obtain and administer grants from senior governments which might  
be made available for such works;  
5. Exercise authority as may be granted, over the operation, main-  
tenance, and control of completed works;  
6. Administer authority over such land conservation measures as  
may be granted to the Authority.  
AND WHEREAS this Council appreciates that some authority may have  
to be transferred from the Municipality to such an authority;  
NOW THEREFORE be it resolved that the Council of this Municipality  
hereby expresses its agreement to such a proposal, and hereby re-  
quests the Government of the Province of Manitoba to consider the  
establishment of legislation whereby such Conservation Area could  
be established and operated, and provided with the necessary author-  
ity to carry out the above described duties. Carried

Accounts O.Bunkowsky-E.Saurette: That the accounts as approved by the Finance  
Committee for ~~\$490~~ \$60,421.46, being the balance of accounts for 1957,  
and of \$1,338.37 for January accounts in 1958, be passed for payment.  
Carried.
