Representative Otto Bunkowsky-Wm. Recksiedler: That we appoint Bruce MacKenzie of Morris Re. R.R.V.W.C. as our representative to the "Red River Valley Water Commission"

Request for survey

B. W. Thiessen-Otto Bunkowsky: That we request the Drainage Maintenance Board to survey the road on the boundary road between the municipalities of Roland and Morris lying West of Section 19, 30 and 31, Twp. 4, Range 2 W.P.M.

Purchase of Montcalm equity in Court House Bldg.

Wm. Recksiedler-Ed. Saurette: Whereas the Rural Municipality of Montcalm has offered to sell its equity in the Court House Building at Morris to the Rural Municipality of Morris for the sum of \$1.00; Now therefore, the Council of the Rural Municipality of Morris accepts this offer and instructs that the necessary agreement be prepared and transfer of this equity be completed. Carried.

Arbitrator Appointed. Wm. Recksiedler-Ed. Saurette; That we appoint Ted Macdonald of Aubigny as arbitrator re the petition of Gerard Touzin et al, requesting the transfer of the lands of Youville S.D. No.942 to the proposed Consolidated School District of St. Jean, if and when said Consolidated School Bistrict is formed. Carried.

Grant to Museum-at Austin.

Wm. Schellenberg-Otto Bunkowsky: That we grant the Agricultural Museum of Manitoba, Austin, the sum of \$25.00 towards the development of said museum.

Arbitrators Appointed.

Ed. Saurette-M. Ribordy: That mexapperintxM. J. Stevenson of Silver Plains and Noel Alarie of St. Elizabeth be appointed arbitrators to consider the petition of Claude Robert and others, requesting the dissolution of Bourret S.D. No. 1077 and annexing its lands to the Provencher S.D.

Dust Layer on No. 23

Request for B. W. Thiessen-Wm. Schellenberg: That we request the Dept. of Public Works to spread dust layer on that portion of P.T.H. No.23 running through the village of Lowe Farm and being the width of the right of way of said Highway.

Sec. Course. Ed. Saurette-B. W. Thiessen: That we authorize the closing of the office from June 17 to June 20th, when the office staff is attending the course in Municipal Administration and Public Finance and that registration, living and travelling expense incurred during this time be paid by the municipality. Carried.

The C.N.R. s request for the removal of the caretaker at the Silver Plains station was objected to.
