The Council of the Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The minutes of the October 10th Council meeting were read and adopted by motion of B. W. Thiessen and Otto Bunkowsky.

No penalty on tax payments made in November.

Otto Bunkowsky-Ed. Saurette: Due to shortage of grain quotas, be it resolved that tax payments during the month of November 1958 be accepted without the usual penalty charge.

Kronsgart Drain.

Wm. Recksiedler-B. W. Thiessen: That we request the Drainage Maintenance Board to reroute the mouth of the Kronsgart Drain across Sections 8 and 9 in Township 4, Range 1 E.P.M.

300 Lengths Piling Ordered.

WM. Recksiedler-Otto Bunkowsky: That we order 300 lengths of piling from Joseph Delorme of Marchand, Man., with the following specifications:
150 of 20' lengths with not less than 8" tops;
and

150 of 15' lengths with not less than 8" tops,
at a price of 35 cents a foot, delivered to our yard at Morris.
Said piling will be scaled at the yard and any piling that is not straight or does not meet the above specifications will not be accepted or paid for.

Request for Snow-Plowing Grant.

Otto Bunkowsky-Ed Saurette: That we request the Dept. of Public Works for a snow-plowing grant for the 1958-59 season on the Main Market roads of the Municipality, which have been previously determined by the Province and the Municipality.

Wm. Schellenberg-M. Ribordy: That we agree to sell that portion of SW 12-6-2W as described in CT17534 to the Mennonite Brethren Church of Sperling for the sum of \$1.00, providing all legal costs involved will be paid for by said church.
