Nurses Residence.

Altona Hosp. B. W. Thiessen-Wm. Recksiedler: That we are in agreeance with the Altona Hospital Districts boards decision to reconsider the planning and construction of a new nurses residence at the Altona Hospital,

Carried.

Dept. of Public Works

- Petition re B. W. Thiessen-Otto Bunkowsky: That we petition the Dept. of Public Works for 60% Grant a Special Grant of 60% for 1959 on the following projects:
 - 1. Gravel $17\frac{1}{2}$ miles due South of Sperling at 400 yards per mile, estimated cost \$22,000.
 - Gravel La Salle Road from Morris to Macdonald boundary. 112 miles at 400 yards per mile at estimated cost of \$13,000.00
 - 3. Construct bridge across Morris River, North of Sec.29-5-1E at an estimated cost of \$9,000.00.

Rent Re Mrs. A. Thiessen Otto Bunkowsky-Wm. F. Schellenberg: That we pay Philip Miller, Morris, fifteen dollars a month rent for the residence of Mrs. Annie Thiessen, retroactive to January 1, 1958.

\$100.00 to Re. Crop Damage.

Otto Bunkowsky-Wm. F. Recksiedler: That we pay C. Sabourin of St. Agathe the C.Sabourin sum of \$100.00 for crop damage caused by our equipment when grading roads.

Tax and Hospital Cancellation and passed. By-Law.

B. W. Thiessen-Wm. F. Recksiedler: That By-Law 858 being a By-Law for the purpose of cancelling certain taxes and hospital accounts, having been read a first time, be now considered as having been read a second and third time

Wages Re. Snow-Plow Operators. Wm. F. Recksiedler-Wm. F. Schellenberg: That we pay the snow-plow operators at \$1.30 per hour and \$100.00 per month commencing December 1, 1958.

Manitoba Hospital Services Plan

Commissions.

M. Ribordy-Wm. F. Schellenberg: That the dommission for premium collections of the Manitoba Hospital Services Plan be allocated as follows: The Municipality - \$200.00 per year.

Balance of commission: D. J. Harder - 65%

Alice Loving - 35%

Should extra help be required to assist in the collection of these premiums, said help to be paid out of commission received and if any balance is remaining, same to be apportioned as stated above.
