Gravel for Approved Market Roads. Otto Bunkowsky-Ed Saurette: That the following gravel be placed on approved Market Roads in the Municipality for 1959:

Special Grant requested for road gravelling Ed. Saurette-Otto Bunkowsky: That we request the Department of Public Works for a Special Grant of 60% of the proposed expenditures on the following projects:

- 1...Gravelling Main Street in the Village of Rosenort - 500 yards. Estimated Cost - \$1,250.00
- 2...Gravelling road to Aubigny Ferry, from P.T.H. #75 and Main Street in Aubigny Village.- 700 yards. Estimated Cost - \$1,750.00

Request to abandon drain. Wm. F. Recksiedler-Otto Bunkowsky: That we request the Drainage Maintenance Board to abandon the drain on the North side of the road allowance N of NW 33-3-1E and North of Sections 32, 31-4-1E and 36, 35, 34, 33-3-1W.

Dr.Mtce. Sec.'s 15, 16 & 17. Wm. F. Schellenberg-Wm. F. Recksiedler: That we request the Drainage Maintenance Board to take over the maintenance of the Coulee and improvements thereto through Sections 15, 16 and 17-4-1E.

School Arbitrator Appointed. Wm. F. Schellenberg-Otto Bunkowsky: That we appoint Noel Alarie of St. Elizabeth as arbitrator regarding the petition of Lorne E. Parker and others requesting the consolidation of the School districts of Union Point #53 and Ste. Agathe #974.

School Arbitrator Appointed. Ed. Saurette-B. W. Thiessen: That we appoint Noel Alarie of St. Elizabeth as arbitrator regarding the petition of L. P. Aubrey and others requesting the consolidation of Ste. Agathe S.D. #974 and the School District of St. Antoine #1097 and the School District of Union Point #52.

Rate By-Law #863. Wm. F. Schellenberg-B. W. Thiessen: That By-Law No. 863, being a By-Law for the purpose of making estimates of all sums required for the lawful purposes of the corporation for the year 1959 and setting out the various rates, as shown in "Schedule A", having been read a first time, be now considered as having been read a second and third time and passed.

Aid Re. Mrs. I. P. Klassen. B. W. Thiessen-M. Ribordy: That we pay Mrs. Isaac P. Klassen of Lowe Farm, Thirty-five dollars a month aid commencing June 1, 1959.

Sec. Course. Wm. F. Recksiedler-B. W. Thiessen: That we authorize the closing of the office during the time the office staff is attending the course in Municipal Administration and that registration, living and travelling expenses incurred during this time be paid by the municipality.

Accounts. Otto Bunkowsky-Ed. Saurette: That the accounts as approved by the Finance Committee for \$18,352.87 be passed for payment.
