The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The minutes of the July 10th Council meeting were read and adopted by motion of Ed. Saurette and B. W. Thiessen.

Approval of Construction of Elderly Persons Home. Wm. F. Schellenberg-B. W. Thiessen: That we approve of "The Evangelical Mennonite Church", a charitable organization, to construct a 20 bed "Elderly Persons Home" at the NE 31-5-1 EPM in the Rural Municipality of Morris, at an estimated cost of \$75,000.00. Carried.

School Arbitrators Appointed. Wm. F. Recksiedler-Wm. F. Schellenberg: That we appoint Robert Skeavington of Sperling and Lawrence Taylor of Morris as arbitrators regarding the petition of Sam Hoffman and others requesting the transfer of the following lands from the Lowe Farm Consolidated S.D. #2377:  
N½ 13-4-1W and S½ 24-4-1W TO DEWET S.D. #2182  
AND  
N½ 24-4-1W and S½ 25-4-1W TO FLOWERY BANK S.D. #837. Carried.

Sperling Legion Hall Tax Exempt. Otto Bunkowsky-Wm. F. Recksiedler; That By-Law No. 865, being a By-Law for the purpose of exempting the "Legion Hall", at Sperling, from taxation, having been read a first time, be now read a second and third time and passed. Carried.

School Division Bus Routes Wm. F. Recksiedler-B. W. Thiessen: That we approve of the School Division BUS ROUTES as outlined on the attached Map. Furthermore, that we request the Dept. of Public Works for a grant of 60% of the cost of re-grading the following portions of said routes, in order to bring them to a suitable standard for bus travel:
