The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The minutes of the September 9th Council meeting were read and adopted by motion of B. W. Thiessen and Otto Bunkowsky.

Grants requested from D.M.B. Re.Coulees on Lewis & Klassen Drains.

Otto Bunkowsky-Wm. F. Schellenberg: That we request the Drainage Maintenance Board for a grant-in-aid on the reconstruction of the coulee on the Lewis Drain through Sec.'s 22 and 23-6-1W; and on the reconstruction of the coulee on the Klassen Drain through Sec. 30-5-1E. Work to be commenced at the earliest possible date. \$1800

Piling Ordered from J. Delorme.

Wm. F. Schellenberg-Otto Bunkowsky: That we order 300 lengths of piling from Joseph Delorme of Marchand with the following specifications:
150 Lengths of 20 foot and
150 Lengths of 15 foot, with not less than 8 inch tops, at a price of 35 cents a foot, delivered to our Yard at Morris.
Said piling will be scaled at the yard and any piling that is not straight or does not meet the above specifications will be rejected.

2 Street Lights requested for Aubigny.

Ed. Saurette-Otto Bunkowsky: That we request the Manitoba Power Commission to install 2 street lights in the Village at Aubigny at the following locations:
1. SE corner of Lot 6 - (150 Watt) And
2. On Road Allowance SW corner of Stan Robert property (150 Watt)
Installation to be made at an early date.

Manitoba Hospital Services Plan Commissions.

Wm. F. Schellenberg-Ed. Saurette: That the commission for premium collections of the Manitoba Hospital Services Plan be allocated as follows:
The Municipality - \$200.00 per year.
D. J. Harder 50% of Balance
And
Alice Loving 50% of Balance.
Should extra help be required to assist in the collection of these premiums, said help to be paid out of commissions.
