JANUARY 13, 1961.

The Council of The Rural Municipality of Morris held its regular monthly meeting on the above date with all members present. The minutes of the December 9th Council meeting were read and adopted by motion of Wm. F. Schellenberg and Wm. F. Recksiedler.

- Municipal Aid. Ed. Saurette-Otto Bunkowsky: That we pay Theo Berard \$40.00 a month aid commencing January 1, 1961. Carried.
- Water Commission Member. Ed. Saurette-Wm. F. Recksiedler: That we appoint Bruce MacKenzie as our member to the Lower Red River Valley Water Commission for 1961 & 1962. Carried.
- Request to enlarge D.M.D. "X". Ed. Saurette-Wm. F. Recksiedler: That we request the Drainage Maintenance Board to include the following Coulee Outlets into D.M.D. "X".
Location River Lot 370, River Lot 384, River Lot 392 and that the Drain through R.L.'s 434 to 450 be included in D.M.D. "X". Carried.
- Request to divert drain. Ed. Saurette-B. W. Thiessen: That we request the Drainage Maintenance Board to survey the feasibility of diverting the drain running NW^{ly} across Sections 5 and 8-5-2E and construct a drain due North from NE 5-5-2E ½ mile North, thence West to Coulee, or, ½ mile West of NE 5-5-2E, thence North to Coulee. Carried.
- Diesel Fuel tender. Wm. F. Schellenberg-Otto Bunkowsky: That we tender for lowest price of Diesel Fuel to be delivered to our municipal equipment during 1961. Carried.
- Oil & Grease Tender. B. W. Thiessen-Otto Bunkowsky: That we tender for Oils & Greases to be delivered to our municipal equipment during 1961. Lowest price not necessarily accepted. Carried.
